Course Description

Basic concepts in biological software applications and will cover multiple computer languages and biological topics.

Course Purpose

This course covers foundational programming skills, data visualization, git-based version control, and principles of data science as they relate to biological research. We'll primarily be using R. Each graduate student will design and implement an independent project that is relevant

to their thesis and falls under the scope of the class (e.g., designing a software package, developing a research pipeline, implementing advanced analytical methods, etc).

Student Learning Outcomes

By the end of the course, students should know how to

- program in base R and the tidyverse
- make publication-quality figures using ggplot2
- collaborate on projects using git/GitHub
- make high-quality markdown-based publications, including how to author
 - reproducible examples for getting help on forums (e.g. StackOverflow)
 - personal research website
 - open-source books
- install and use unix-based / command line programs
- learn how to access and start learning other programming languages (e.g. Python, C++)

Methods of Evaluation and Grading Methods

Assignment categories include:

- **Homework assignments (25%)** due each Tuesday before class.

- **Final project (25%)**. Details will be provided throughout the semester. **Graduate students will have additional requirements.**

Unless otherwise indicated, all assignments are **individual, open book, open notes, and open internet**. You may not post questions related to course content on forums (e.g. StackOverflow, StackExchange) during the semester, but you may post such questions to **Webcourses Discussions** instead.
