**Framework of Course**: In this course you will be observing, documenting, and analyzing animal behavior at the Central Florida Zoo and Botanical Gardens using techniques in animal behavior research. You will present your data in written format through two term papers.

**Requirements:** The course in many ways is a directed independent study. It will be your responsibility to maintain a self-directed observation schedule at the Central Florida Zoo and Botanical Gardens.

**Assignments:** You will coordinate with the Central Florida Zoo and Botanical Gardens to determine what species you will be studying and what the nature of your project will be. You will be required to successfully complete the following tasks:

- 1) On the first week there will be an orientation meeting where we will discuss what your study will be about, how to record your observations in accordance with proper research methods and how to submit your observations.
- 2) You will make weekly observations of the animal (-s) and behavior (-s) in coordination with the Central Florida Zoo and Botanical Gardens. These observations will be due by 4:50pm on the Friday of that week and must be emailed to the instructor as an MS Word document.
- 3) Your observations will be submitted weekly excepting Spring Break. They can be submitted electronically.
- 4) Your first paper is due on Friday, March 24. <u>The paper will describe your</u> <u>observations. You will need to do a literature search and include it in your paper if</u> <u>the observed behaviors are documented as occurring in the wild.</u> The paper will also <u>include your conclusions</u>. The paper should be of an appropriate length to adequately cover the assignment and should adhere to standard format. The paper must be emailed to the instructor as an MS Word document.
- 5) Later that week the student and instructor will meet, as requested by the student, at a time to be determined to discuss your paper.
- 6) Your second paper is due on Friday, April 21. <u>This paper will be an advancement of</u> your first paper including your new observations. You will discuss the evolutionary and survival significance of your observed behaviors. Because each study will be different, the paper requirements will study specific. The paper must be emailed to the instructor as an MS Word document.
- 7) Later that week the student and instructor will meet as requested by the student, at a time to be determined to discuss your paper.

### Research Experience in Animal Behavior in a Zoo Environment Spring 2024 Syllabus

**Learning Outcomes:** The purpose of this course is to give you an understanding of conducting animal research, reviewing and evaluating scientific literature, data collection and analysis, and writing scientific papers.

**Assignments:** You will coordinate with the Central Florida Zoo and Botanical Gardens to determine what species you will be studying and what the nature of your project will be. You will be required to successfully complete the following tasks:
