This summary of distinguished professional contributions describes various efforts since my 2007 promotion to full professor by focusing on the complementarity of my roles as professor of political science and associate director of the Lou Frey Institute/content specialist of the Florida Joint Center for Citizenship (LFI/FJCC).<sup>1</sup>

Upon promotion, I continued my teaching, research, and service, focusing on American politics with an emphasis on political participation and the role of minority groups in the political process. I served in leadership roles that included membership on or chairing university, college, and department/school committees.<sup>2</sup> I served as faculty advisor to three student groups and fulfilled profession-related roles that included membership on or chairing professional association committees, serving on journal editorial boards, reviewing manuscripts, publishing book reviews, participating in conference panels, reviewing books, and writing external tenure and promotion letters. I continued developing and teaching new courses in various modalities, presenting my work at conferences, publishing journal articles and book chapters, and co-authored a book.

I was offered the opportunity to maintain that active teaching, research and service record while serving as the LFI Associate Director/Content Specialist for FJCC. The role included a fall/spring course release and occasional summer support. This opportunity focused on supporting implementation of the Sandra Day O'Connor Civics Education Act, enacted in Florida in 2010. With that legislation, Florida became the only state to mandate K-12 civic education, require that middle school students complete a full civics course, and take a state-developed End of Course Assessment (EOCA). I created and shaped the position, bringing my academic expertise and teaching experience to the K-12 space, working with K-12 teachers and developing curricular, content and assessment materials for teacher and student use.

There were times when these two roles "merged", giving me the opportunity to bring my professorial role into my LFI/FJCC administrative work. This document outlines that intersection and the ways that it fostered distinguished professional accomplishments as my political science expertise and skills complemented by civic education administrative work.
