At the same time, a growing number consider themselves Hispanic or Latino (and less commonly Latinx) in some contexts, such as responding to census questionnaires or during presidential elections. This research project will probe under what conditions and with what results immigrants from the insular Hispanic Caribbean (Cuba, the Dominican Republic, and Puerto Rico) and their descendants "cross Latinidades" and identify with other groups of Latin American origin in the United States.
